**For Project Engineer- I:** First class for General, OBC & EWS Candidates and Pass Class for SC/ST/PWD (Person with Disability) candidates in BE / B. Tech /B.Sc.- Engg (4 Years course) in Aerospace Engineering from a AICTE recognized University/ Institution.

#### OR

First class for General, OBC & EWS Candidates and Pass Class for SC/ST/PWD (Person with Disability) candidates in M.E/M.Tech in Aerospace Engineering from a AICTE recognized University/ Institution. Candidates applying with ME/M.Tech Qualification under this post should compulsorily have Aerospace Engg in their BE/B. Tech/ B.Sc. Engg. Degree.

#### 2. **Age:**

25 Years for Trainee Engineers-I and 28 Years for Project Engineers-I and less as on 01.12.2020. The upper age limit indicated is for candidates belonging to General & EWS Category.
