1. The Commissioner of Health and Family Welfare, AP, Vijayawada has issued orders to fill up the 34 posts of Paramedical Ophthalmic Assistants on outsourcing basis through APCOS for a period of 01 year for implementation of Dr. YSR Kanti Velugu duly following the guidelines.
2. **Hence the eligible and interested candidates are hereby requested to apply for the posts in offline.**

3. **AGE:** The age limit of the above said posts is for the general Category (OC) 42 Years and for Reservation Category (BC, SC, ST) 5 Years more and for PH Candidates get more 10 years as per rules. The cutoff date is 01.12.2020.

4. **METHOD OF SELECTION:** As per G.O.Ms.No.217 HM&FW (J2) Dept., dated: 26.02.2001.

A. **Selection Process:**

- i. Total Marks –100.
- ii. For the post of Paramedical Ophthalmic Assistants out of a total of 100 marks 45 marks shall be allotted against the marks obtained in the academic qualification, 45 marks shall be allotted against the marks obtained in technical examination and 10 marks for weight age from the date of passing of technical examination @ 1 mark per year.

5. **RULE OF RESERVATION:** Selection will be strictly as per the merit and rule of reservation as per AP State and Subordinate Service rules, 1996.

6. **SELECTION COMMITTEE:** The selection will be through the District Selection Committee, Kurnool. The Committee members are as follows as per Govt. Memo.No. GAD 01 – SUOMISC/31/2019 – SU-1; Dated:20.11.2019.

7. **RULE OF RESERVATION TO LOCAL CANDIDATES:**

This will be as per the instructions as per the Commissioner of Health & Family Welfare, A.P, Gollapudi, Vijayawada.

8. **SERVICE CONDITIONS:**

- a. That the individual should execute agreement on a Non - Judicial Stamp Paper worth Rs.110/- and to submit the same to the Medical Officer / DDO concerned at the time of joining.
- b. That the individual should reside at his / her bonafied head quarters and available 24 X 7.
- c. That this temporary appointment on outsourcing basis does not confer any right for their appointment on contract / regular basis.
- d. That this appointment is subject to the result of court cases of the Hon'ble Courts if any.
- e. That he / she has to discharge his / her duties under the control of **District Blindness Control Society, Kurnool** at which he / she is posted to the entire satisfaction to their superiors and in case of default they will be liable for termination without any notice.
- f. The individuals are not eligible for any kind of leave except Casual Leaves as per rules in force.
- g. That the candidate should report for duty before the DDO concerned within **07 days** from the date of receipt of the order. If the candidate fails to join within the stipulated time, the appointment is automatically cancelled.
- h. That the certificates submitted by the candidate for this appointment is found false at any time, he / she is liable for termination from service without any prior notice.
- i. Disciplinary procedure will be adopted in accordance to the provisions of APCS (CCA) Rules, 1991.
- j. The individual has to submit Physical Fitness Certificate issued by the Civil Surgeon at the time of joining along with required documents.

9. **DEBARMENT:**

- a. Candidates should make sure of their eligibility to the post applied for and that the declaration made by them in the format of application regarding their eligibility in all respects. Any candidate furnishing in-correct information or making false declaration regarding his/her eligibility at any stage or suppressing any information is liable to be debarred from recruitment conducted by the department and summarily rejection of their candidature for this recruitment & future recruitments.

- b. The department is vested with duty of conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process and any attempt.
- c. The Act by any one causing or likely to cause breach of duty in such manner or by such action as to violate or likely to violate the fair practices followed and ensured by the Department will be sufficient cause for rendering such questionable means ground for department.

10. **DEPARTMENT DECISION IS FINAL:**

The decision of the department pertaining to the application and its acceptance or rejection as the case may be conduct of counseling and at all consequent stages culminating in the selection or otherwise of any candidate shall be final in all respects and binding on all concerned under the powers vested with it. The department also reserves its right and modify regarding time and conditions laid down in the notification for conducting the various stages up to selection duly intimating details thereof to all concerned as warranted by any unforeseen circumstances arising during the course of this process.

11. **Fee:** The candidates applying for the post should invariably enclose Demand draft obtained in favor of District Medical and Health Officer, Kurnool for Rs.300/- only.
