

Besides the above Initial Basic Pay, DA, HRA or company accommodation, Medical Allowance, Conveyance allowance, reimbursement of medical expenses, group insurance, LTC, Gratuity, New Pension Scheme( NPS) and various loans & advances shall be paid as per applicable rules of the Corporation in force from time to time. #### D. TRAINING

Selected candidates have to undergo training for a period of 1(one) year at field units of OPTCL including induction training at Power Training Centre (PTC), Chandaka. Bhubaneswar. The training period will be for 1(one) year, unless and otherwise extended further. During the training period, the trainees may be terminated without any notice or without assigning any reasons thereof. After successful completion of training, there shall be no obligation on the part of the Corporation to offer regular appointment.

#### E. SERVICE AGREEMENT BOND

The selected Management Trainees have to execute a Training & Service Bond on Non-Judicial Stamp paper to serve the Corporation for a period of three years after successful completion of training.

#### G. AGE

- i. Candidate must not be under 21 (twenty one) years of age and must not be above 32(thirty two) years as on 07.12.2020 i.e. she / he must not have been born earlier than 07.12.1988, and not later than 07.12.1999.
- ii. Relaxation for SC / ST/ SEBC:The upper age limit is relaxable by 5 (five) years in case of SC, ST and SEBC candidates.
- iii. The upper age limit is relaxable by 5 (five) years in case of Woman candidates.
- iv. The upper age limit is relaxable by 10 (ten) years in case of PWD Candidates.
- v. Provided that a person who comes under more than one category mentioned above, shall be eligible for only one benefit of upper age relaxation, which shall be considered most beneficial to him/her.
- vi. The date of birth entered in the High School Certificate Examination or equivalent Certificate issued by the concerned Board / Council will only be accepted.

#### H. RESERVATION

i. Reservation of posts including reservation for Women will be as per the ORV and other

- applicable Acts and rules of Government of Odisha.
- ii. **PWD candidates**, whose disability is not less than 40% (forty percent), are required to submit Disability Certificate indicating percentage of disability & type of disability issued by the concerned Medical board for consideration as per Rules at the time of Document Verification.
- iii. Concession meant for SC, ST and SEBC by birth are admissible to the Scheduled Castes, Scheduled Tribes and Socially and Educationally Backward Classes of Odisha State only.
- iv. The Competent Authorities to issue the caste certificate are: District magistrate / Collector or Additional District magistrate or Sub-Divisional Magistrate / sub-Collectors or Executive Magistrates or Revenue Officers, not below the rank of Tahasildar / Additional Tahasildar of Government of Odisha.
- v. Candidates belonging to PWD, shall be adjusted against the categories to which they belong.
- vi. In the event of non-availability or insufficient number of eligible / suitable women candidates belonging to any particular category, the vacancies or the remaining vacancies shall be filled up by male candidates of the same category.
- vii. Exchange of reservation between Scheduled caste and Scheduled Tribe will not be considered.
- viii. Candidates belonging to SEBC category shall submit their SEBC Certificate validated / renewed by the Competent Authority on or after, 07.12.2017 failing which they shall be treated as unreserved category candidates.
- ix. Women candidates belonging to SC/ST/SEBC are required to submit Caste Certificate by birth showing "daughter of .............." Caste Certificate obtained by virtue of marriage i.e. showing "wife of ............" is not acceptable. The same is to be submitted at the time of Document Verification.
- x. OBC Certificates will not be accepted in lieu of SEBC Certificate.
- xi. Community (Caste Status) once mentioned by the candidates shall not be changed under any circumstances.

#### I. HEALTH

- i. Appointment of selected candidates will be subject to having sound health and being physically & mentally fit in the Pre-Employment Medical Examination to be conducted as per the norms and standards of Medical Fitness.
- ii. Candidates selected under PWD category must be within the prescribed normal range for all other physical standard. The PWD candidates will have to undergo a verification

process by the authorized Medical Board on the date specified failing which the candidature of the candidate will be forfeited.

#### J. PROVISION FOR DEPARTMENTAL CANDIDATES

Departmental candidates (OPTCL regular employees only) fulfilling the eligibility criteria may apply against this advertisement through proper channel to **CGM (HRD) Hqrs. Office**, **OPTCL** so as to reach within the stipulated time period. They shall also submit the online application form. There shall be no age bar for them and they are exempted from payment of application fees.

Note: The children of the employee and the candidates engaged through outsourced agency not to be considered as Departmental candidates.

## K. OTHER ELIGIBILITY CONDITIONS

- i. The candidate must be a citizen of India.
- ii. She / he must be able to read, write and speak Odia fluently and must have:
  - a. Passed Middle School Examination with Odia language subject; or
  - b. Passed Matriculation or examination with Odia as medium of examination in nonlanguage subject; or
  - c. Passed in Odia as language subject in the final examination of class VII from a school or educational institution recognized by the Government of Odisha or the Central Government.
  - d. Passed a test in Odia in Middle English School Standard conducted by the School and Mass Education Department.
- iii. A candidate who has more than one spouse living will not be eligible for appointment unless the State Government has exempted his / her case from operation of this limitation for any good and sufficient reasons.
- iv. The candidates must have a good character.
- v. Candidates, who fulfill the prescribed eligibility criteria, may apply for the post.

#### L. SELECTION PROCEDURE

The selection methodology for Management Trainee (Electrical) will comprise of the following:

i. Candidate should have appeared in the GATE-2020 Paper – Electrical Engineering (Paper code-EE)) having valid score in the concerned discipline.

- ii. Valid GATE-2020 score is applicable for this recruitment in OPTCL under this advertisement. Score from GATE-2018, 2019 or from any previous GATE examination is not valid.
- iii. On the basis of GATE-2020 score, the candidates will be short listed in 1:3 ratio for further selection process comprising of Personal Interview (PI) for assessment of different facets of knowledge, skills etc.
- iv. Candidates have to essentially qualify in the GATE-2020 examination. In addition, candidates will have to separately qualify in Personal Interview (PI) successfully before being adjudged as suitable for selection.
- v. The offer of appointment shall be issued to the selected candidates on the basis of merit.

  However the final appointment of selected candidates will be subject to their <u>medical</u>

  <u>fitness</u> as per the prescribed standard.
- vi. On selection, candidates can be posted at any of the existing / future units of OPTCL throughout Odisha.

- i. UR and SEBC candidates are required to pay a non-refundable fee of Rs.1000/(Rupees one thousand) only and Candidates belonging to scheduled Caste (SC) /
  Scheduled Tribe (ST) of Odisha only, PWD candidates are required to pay a nonrefundable fee of Rs.500/- (Rupees five hundred) only. OPTCL departmental
  candidates are exempted from payment of this fee. However, the departmental
  candidates must have the valid GATE Score of 2020.
- ii. Candidates shall be required to make the payment of fee while filling up online application in on-line mode only.
- iii. For On-line Payment mode (Through Debit / Credit Card / Net Banking): For On-line payment mode, an applicant will be redirected to payment gateway page under Tech Process. After completing the On-line Payment, she / he shall take hard copy of the application form along with Fee Receipt. She/he shall retain the hard copy and proof of payment for future reference / record which shall be required at the time of verification of original certificates / testimonials as and when necessary. The candidate shall bear the online transaction charges extra as applicable.
