- Note 1: The number of posts may be increased or decreased by the govt. at any time before the selection process is complete without giving any prior notice to the candidates.
- Note 2: The Punjab Civil Service (Reservation for Women) Rules, 2020 issued by the Department of Social Security that provides for 33% reservation for Women is attached as Annexure with General Information for Candidates.

2. ESSENTIAL QUALIFICATIONS:-

- (i) The candidate should possess a Bachelor's degree in any discipline from a recognised university or institution. Provided that the candidate may be permitted to take Preliminary Competitive Examination while studying for his degree. However, the candidate shall be required to produce proof of passing the degree course for being eligible to take the Main Competitive Examination during that year.
- (ii) No candidate shall be eligible for appearing in the Preliminary Competitive Examination, unless he/she has passed the Matriculation Examination with Punjabi as one of the compulsory or elective subjects or any other equivalent examination in Punjabi language, which may be specified by the Government from time to time.

AGE:

3.1 As mandated by Punjab State Civil Services (Appointment by Combined Competitive Examination) Rules, 2009 read with Punjab Civil Services (Executive Branch) Rules 1976, and Govt. instructions issued from time to time, the candidate should have **attained the minimum age of 21 years and should not have attained the age of 37 years** on the first day of January of the year in which the last day for submission of application to the Commission falls. In other words, the candidate should have attained the age of 21 years but should not be older than 37 years on 1st January 2020.

- 3.2 The Upper age limit may be relaxed up to 42 years for Scheduled Castes and Backward Classes of Punjab only in case of other services except Punjab Police Service and Punjab Prisons Service.
- 3.3 Upper age limit may be relaxed up to 45 years for Punjab Govt. and its Board/Corporation/Commission and Authorities employees, all States/ Central Government employees. However no age relaxation is permissible for Punjab Police Service.
- 3.4 Ex-servicemen of Punjab Domicile shall be allowed to deduct the period of his service in the Armed Forces of Union from his actual age and if the resultant age does not exceed the maximum age limit prescribed for direct appointment to such a vacancy in the Service Rules concerned by more than three years, he shall be deemed to satisfy the condition regarding age limit.
- 3.5 Upper age limit may be relaxed up to 42 years for Widows, Divorced women and certain other Categories of women. However no age relaxation is permissible for women in case of Punjab Police Service and Punjab Prisons Service.
- 3.6 Upper age limit may be relaxed up to 47 years for Physically Handicapped of Punjab only. However no age relaxation is permissible in case of Punjab Police Service and Punjab Prisons Service.
- 3.7 In the case of the post of Deputy Superintendent Police and Deputy Superintendent Jails/District Probation Officer (Grade-II) in Punjab Police Service and Punjab Prisons Service, a candidate should have attained the minimum age of 21 years and should not have attained the age of 28 years on the first day of the year, as referred to above.
- 3.8 The Upper age limit may be relaxed up to 33 years for Scheduled Castes and Backward Classes of Punjab only in case of Punjab Police Service and Punjab Prisons Service.
- 4. The minimum pay admissible for the ibid posts shall be <u>as per the notification of Finance</u> <u>department dated 05/12/2020 and as per Notification No. 7/204/2012-4FP1/66, Dated</u> <u>15/01/2015 Govt. of Punjab, Department of Finance (Finance Personnel-I Branch)</u> <u>Chandigarh, and Notification No. 1/62016-4P.P.1/834680/1 dated 07/09/2016</u> <u>Govt. of Punjab,Department of Personnel PP-I Branch Chandigarh, fixed</u> <u>emolument equal to Minimum Pay without any allowance will be paid during the</u> <u>probation period of 3 years</u>.
- **5.** Last date for Filling Online Application Form : $\frac{30/12}{2020}$
- 6. The Preliminary Combined Competitive Examination-2020 is tentatively scheduled in Feburary, 2021. Exact date for the Preliminary examination shall be intimated later on.

IMPORTANT NOTICE :

- 1. The candidates who had already applied for the PCS & allied services posts as per the earlier PPSC Advertisement No. 8 published dated 05/06/2020 SHOULD NOT apply again. Their applications already registered with the PPSC stand valid for their Candidature for this advertisement subject to fulfilling the eligibility conditions as per this new advertisement.
- 2. Those Candidates who had applied under the Sports Category in response to earlier advertisement no. 8 dated 05/06/2020 who are now not eligible for Sports Category as per the amended "the Punjab Recruitment of Sportsmen(First Amendment) Rules, 2020" will be considered in their respective basic category.
- The candidates can <u>ONLY</u> apply by Filling Online Application Form, a link of which is available on the website of the Punjab Public Service Commission <u>www.ppsc.gov.in</u>. Further, the candidates are <u>NOT REQUIRED</u> to send the Hard Copy of the Online Application Form to the office of Punjab Public Service Commission.
- 4. <u>MUST</u>:

a) However, **candidates applying under the Sports Category** need to submit a hard copy of 'Online Application Form' along with Sports Gradation Certificate and other certificates related to sports to establish his eligibility under the sports category at the reception counter of PPSC by hand by 30/12/2020.

- b) Also, **Persons with disabilities must submit the hardcopies** of Online Application Form along with Disability Certificate and request for scribe, if any and other eligibility documents at the reception counter of PPSC by hand by 30/12/2020..For any assistance Persons with disabilities may contact Superintendent Examination: 0175-5014832.
- 5. Candidates who had applied for the posts as per PPSC advertisement No. 8 published on 05/06/2020 and who now wish to withdraw their candidature due to changes in rules may so by 30/12/2020. The procedure and the link for withdrawal will be uploaded shortly on PPSC website.
