Sub:- Filling up of the post of Assistant in TRAI Regional Office, Jaipur, Kolkata and Bengaluru on deputation on foreign service terms.

Telecom Regulatory Authority of India (TRAI), New Delhi is a statutory body set up under an Act of Parliament viz. TRAI Act, 1997. TRAI has been established to regulate the Telecommunications Services and to protect the interest of service providers and consumers of the telecom sector, to promote and ensure orderly growth of the telecom sector and for matters connected therewith or incidental thereto. The functions relating to regulation of Broadcasting and Cable Services Sectors have also been entrusted to TRAI from 2004.

2. The Organization proposes to fill up of the post of Assistant in its regional offices at Jaipur, Kolkata and Bengaluru on deputation on foreign service terms, initially for a period upto 31st March, 2022. The details of posts and their qualification/ experience etc, are as under:-

(Pay II) dated 17th June, 2010, as amended from time to time. The maximum age for appointment on deputation shall in no case exceed 56 years on the date of closing of applications in TRAI.
