1. Number of Posts-

- i) Chief /Divisional Security Officer-
 - 3-Three (one each to be stationed at Corporate Headquarters Srinagar Zonal Office M.A.Road Srinagar & at Zonal Office Rail Head complex Jammu Central-1)
- ii) Zonal Security Officer-

2. Qualification-

- i) Chief /Divisional Zonal Security Officer-

6. Contract Tenure-

- The contract for engagement of Security Officers will be for a period of three years subject to annual satisfactory performance review. There will not be any renewal of engagement on completion of the contract.
