#### Candidates' selection criteria:

- 1. Candidates will be selected based on the score in Competency Assessment Test (CAT) i.e, 100% on CAT. There will be no viva-voice. Candidates will be selected based on merit.
- 2. The cut of marks for qualifying the written examination is 30% for all categories of candidate's i.e, UR/SC & ST.
- 3. The examination will be conducted for 100 marks in Multiple Choice Question (MCQ) pattern carrying 1 (one) each. For every wrong answer 0.25 marks will be deducted.
- 4. Candidate will be provided with OMR Sheet for answering the questions.
- 5. After finalizing the result on Merit Basis selected candidates will be called for Counselling Session on a scheduled date and time. In this session documents will be verified in original. If any candidate fails to appear or produce the requisite document before the authority, his/her candidature will be cancelled and in this regards no further communication will be entertained. Accordingly, the next candidate as per Merit List will be selected.
