4. The applicants who got degree from the Distance Education Learning will not be eligible and such applications will be rejected directly.
5. The selected candidates shall have to execute the agreement as per the terms and conditions of the department / outsource agency and consultancy fees shall be fixed based on the experience.
6. The appointment of selected candidates is purely on temporary basis. They cannot claim for permanency in their position under any circumstances.
7. The shortlisted candidates shall be called for interview over telephone/e-mail/ any other suitable means. The shortlisted candidates shall have to attend the interview at their own expenses. No TA will be given.
