3. **PAY SCALE:**

Rs. 47600/- initial Pay.

The minimum pay admissible for the ibid posts shall be as per the notification of department dated 12/01/2021 (Annexure A) and as per Notification No. 7/204/2012-4FP1/66, Dated 15/01/2015 Govt. of Punjab, Department of Finance (Finance Personnel-I Branch) Chandigarh, and Notification No. 1/62016-4P.P.1/834680/1 dated 07/09/2016 Govt. of Punjab Department of Personnel PP-I Branch Chandigarh, fixed emolument equal to Minimum Pay without any allowance will be paid during the probation period of 3 years

4. **ESSENTIAL QUALIFICATIONS:**

- (a) Should possess B.E./B.Tech Electrical from a government recognized University or institute.
- (b) Punjabi of Matric or its equivalent standard.

5. **AGE**

Candidates should not be below 18 years and above 37 years of age as on 01.01.2021 (See detail in General Information for candidates).
