3.0 PAY SCALE: 35400/- initial Pay.

4.0 ESSENTIAL QUALIFICATIONS :-

- 4.1 Should pass Diploma in Electrical Engineering or a higher qualification in the same discipline from a recognized university or institution.
- 4.2 Punjabi of Matric or its equivalent Standard.
