2. On selection, the selected candidate has to produce the following Original Certificates invariably during verification of Certificates along with a set of Xerox copies of those certificates.
 - a) Study Certificates from Class I to VII: to ascertain Local Status.
 - b) SSC/its equivalent: for Proof of Date of Birth.
 - c) All Qualifying Certificates for the post (Memo of Marks + Provisional /Original MBBS Degree & P.G. Degree/DNB/ P.G. Diploma).
 - d) Internship Certificate and Registration Certificate from State Medical Council OR Indian Medical Council.
 - e) Latest Caste Certificate issued by the Competent Authority not earlier than six months.
 - f) If employed in Govt. Services, NOC Letter from the HOD of the respective Department is to be produced. Relieving letter is to be submitted at the time of appointment
 - g) Two Latest Passport size photos
 - h) Experience Certificate

The relevant Pass/Provisional/Original Certificate of the qualifying examination should have been dated on **or before 01.04.2022.**

3. Candidates who wish to claim reservation should invariably produce copy of Permanent Caste Certificate recently issued by Revenue Officer not below the rank of Tahsildhar/Mandal Revenue Officer, date of issue of which should not be six months **earlier to 01.04.2022.**
4. Any candidate is or has been found impersonating or deploying any person to impersonate or resorting to any other irregular or improper means in connection with his/her candidature for selection, such a candidate may in addition to rendering himself/herself liable to criminal prosecution, will be debarred permanently from any exam or selection held by the SCCL.

- b)** The Spirit of Presidential Order 2018 as adapted by SCCL Board of Directors is applicable to all the above posts. 40% of posts are earmarked as Un-reserved (Open to all i.e. Local & Non-Local) and 60% of posts are reserved for Local candidates for executive cadre posts. The posts earmarked to Open category will be filled from the combined merit list of the candidates (both local and non-local) based on their overall merit and communal roster. The posts earmarked to local candidates will be filled by local candidates only based on their merit and communal roster point.
- c)** Candidates who intend to avail the Local reservation will have to adduce adequate proof of such local candidature by submitting the following certificates, as the case may be.

(i) RESERVATION TO LOCAL CANDIDATES:

- The candidates claiming reservation as Local candidates should produce the Study certificates (from 1st to 7th class). (Encl-I)

- Residence Certificate in the Proforma (enclosed) only for those candidates who have not studied in any Educational Institutions as the case may be **(Encl-II)**. Subsequent production of the certificates will NOT be entertained under any circumstances.

(ii) DEFINITION OF LOCAL CANDIDATE AS PER RESIDENTIAL ORDER 2018

"LOCAL CANDIDATE" means a candidate for direct recruitment to any post in relation to that Local areas where he/she has studied in Educational Institution(s) for not less than four consecutive academic years prior to and including the year in which he/she first appeared for **7th class** or its equivalent examination. If however, he/she has not studied in any

educational institution during the above four years period, it is enough if he/she has resided in that area which is claimed as his/her local area during the above said period and produce Residence Certificate issued by the Tahsildar.

- (iii) In case the candidate does not fall within the scope of the above it will be considered if he/she has studied for a period of not less than seven years prior to and inclusive of the year in which he/she has studied (first appeared for 7th class or its equivalent examination) for the maximum period out of the said period of seven years AND where the period of his/her study in two or more local areas are equal such local area where he/she has studied last (in such local area) will be taken for determining the local candidature. Similarly, if he/she has not studied during the above said period in any Educational Institution(s) the place of residence during the above period will be taken into consideration and local candidature determined with reference to the maximum period of residence or in the case of equal period where he/she has resided last.
- (iv) If the claim for local candidature is based on study, the candidate is required to produce a certificate from the Educational Institution(s) where he/she has studied during the said 4/7 year period as prescribed in **Enclosure-I**. If, however, it is based on residence, a certificate should be submitted as prescribed in **Enclosure-II** obtained from an officer of the Revenue department not below the rank of a Mandal Revenue Officer in independent charge of a Mandal.
- (v) If, however, a candidate has resided in more than one Mandal during the relevant four/seven years period but within the same District or Zone as the case may be separate certificates from the Mandal Revenue Officers exercising jurisdiction have to be obtained in respect of different areas.

NOTE:

SINGLE CERTIFICATE, WHETHER OF STUDY OR RESIDENCE WOULD SUFFICE FOR ENABLING THE CANDIDATE TO APPLY AS A "**LOCAL CANDIDATE**".

RESIDENCE CERTIFICATE WILL NOT BE ACCEPTED, IF A CANDIDATE HAS STUDIED IN ANY EDUCATIONAL INSTITUTION UPTO **7th class**/ITS EQUIVALENT EXAMINATION, SUCH CANDIDATES HAVE TO PRODUCE STUDY CERTIFICATES INVARIABLY.
