**Recruitment to the posts of Assistant Professor (Broad Speciality) of Government MCHs
in the rank of Group-A, under Health & Family Welfare Department, Odisha.**

Online applications are invited from the prospective candidates through the proforma application to be made available on the Website of the Commission (<http://opsc.gov.in>). The link for registration /re- registration shall be available from 22.01.2023 to 17.02.2023 (Note: 17.02.2023 is the last date for submission of Registered Online Application) for recruitment to 274(65-w) (Two Hundred Seventy Four) posts of Assistant Professor (Broad Speciality) in Group-A, under the Odisha Medical Education Service cadre, for posting in Government MCHs of the State of Odisha, under Health & Family Welfare Department in the Academic Level-12 of ORSP (MCT) Rules, 2019 with usual dearness and other allowances as may be sanctioned by the Government of Odisha from time to time. The posts are purely temporary for the present and likely to be made permanent in future.

NOTE:

- In the event of non-availability or availability of insufficient number of eligible women candidate(s) belonging to any particular category, the remaining vacancies will be filled up by male candidate(s) of that category.
- Exchange of reservation between Scheduled Caste and Scheduled Tribe will not be considered in the event of non-availability of eligible and suitable S.C./S.T. candidates .
- The number of vacancy to be filled up on the basis of this recruitment is subject to change by Government without notice, depending upon the exigencies of public service at the discretion of the State Government.

3. AGE: A candidate must have attained the age of **21(twenty one)** years and must not be above the age of **45 (Forty five)** years on the **1st day of January 2022** i.e. he/she must have been born **not earlier than 2nd January 1977** and **not later than 1st January 2001**.

The upper age limit prescribed above shall be relax-able by 5 (five) years for candidates belonging to the categories of Socially & Educationally Backward Classes (S.E.B.C), Scheduled Castes (S.C.), Scheduled Tribes (S.T.) ,Women & Ex-Servicemen .

Provided that, the upper age limit shall be relaxed up to 5(Five) years in case of in-service Doctors serving on ad hoc basis or contractual basis under the Government or Government undertakings as the case may be.

(SAVE AS PROVIDED ABOVE THE AGE LIMITS PRESCRIBED CAN IN NO CASE BE RELAXED).

Date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council will only be accepted by the Commission.

4. EDUCATIONAL QUALIFICATION:

(A) In order to be eligible for direct recruitment, a candidate must –

(i) Have acquired a Post Graduate Degree in the concerned Broad Speciality or any other equivalent degree or qualification prescribed by the MCI/NMC from time to time.

(ii) Those candidates who have undergone Diplomate National Board training in concerned subject are also eligible for the post of Assistant Professor subject to fulfilling of any other criteria regarding Diplomate National Board, prescribed by MCI/NMC from time to time in force.

(iii) The candidates who are already appointed as Assistant Professor in a Medical College without experience as SR as per previous guidelines before 08.06.2017 shall not require the one year experience as SR for applying for Assistant Professor in another Medical College.

(iv) The candidates who are already working as Asst. Professor before 08.06.2017 to undergo SR ship, they are exempted from the teaching experience requirement of one year in the concerned subject.

5. METHOD OF SELECTION: The selection of candidates for recruitment to the post of Assistant Professor in Broad Speciality shall be made on the basis of **Written Test** as per the guidelines as enumerated in Odisha Medical Education Service (Method of Recruitment and Conditions of Service) Rules, 2021.

Provided that the recruitment may also be made by way of selection from amongst the Assistant Professors in any other Broad Speciality subject, having requisite qualification in the concerned Speciality subject to the condition that seniority in the Broad Speciality in the said discipline as the case may be shall be determined from the date of appointment in the new discipline in accordance with the placement given by the Commission and accepted by the Government.

Provided further that in case of non-availability of MD/MS/DNB candidates in the discipline of Anatomy, Bio-chemistry and Physiology, non-medical teachers possessing M.Sc. degree (along with Ph.D) in concerned subject or M.Sc. in Medical Anatomy, Bio-chemistry and Physiology (along with Ph.D) shall be appointed to the extent of 15% (fifteen per cent) of the total number of posts in these disciplines.

Written test will be conducted in the following manner:-

- (i) **Total marks** in written test - **200**;
- (ii) Total **No. of questions shall be 200**, which shall be of Multiple Choice Questions (**MCQ**) pattern;
- (iii) **There shall be negative marking** for wrong answers. For each wrong answer **0.25 marks** shall be deducted from the marks awarded for correct answers.
- (iv) **The qualifying marks in the written examination shall be as decided by the Commission.**
- (v) **Duration of Examination - 3 hours;**
- (vi) **Syllabus:** – (a) The syllabus for the post of Assistant Professor (Broad Speciality) shall be from Broad Speciality Subjects i.e as per MCI approved MD/MS syllabus.
(b) For Medical M.Sc., the syllabus approved by the University for Medical M.Sc. courses.

Candidates who are native or resident of Odisha shall be given preference over candidates of other states.

The Commission shall prepare a list of candidates in order of merit on the basis of written test, which shall be equal to the number of advertised vacancies;

Provided that, if two or more candidates secure equal marks, then the candidate securing higher marks in MBBS Examination shall find place above the other in the merit list. In case marks obtained in MBBS Examination is also the same, the candidate older in age shall be placed above the younger.

The list recommended by the Commission shall remain valid for a period of one (01) year from the date of its approval by the Government.

Note:- Any details relating to this recruitment like cut-off marks, answer keys, individual marks etc. shall only be declared on the website of the Commission after publication of the final results and select list.

6. PLACE OF EXAMINATION

The written examination for the post of Assistant Professor (Broad Speciality) will be held at Cuttack. The programme of examination shall be notified well in advance.

7. OTHER ELIGIBILITY CONDITIONS:

- (i) The candidate must be a citizen of India;
- (ii) The candidate must be of (a) good moral character, and (b) good mental condition and bodily health, good physique and active habits and free from organic defects or bodily infirmity so as not to create an impairment in the due discharge of duties;
- (iii) A candidate, who has more than one spouse living, will not be eligible for appointment unless the State Government has exempted his/her case from operation of this limitation for any good and sufficient reasons;
- (iv) Government servants, whether temporary or permanent, are eligible to apply provided that they possess the requisite qualification and are within the prescribed age-limit as provided under Para 3 & 4 of the Advertisement. They must inform their respective Heads of the Office in writing regarding submission of their application for this recruitment and furnish "No Objection Certificate" during document verification;
- (v) **Concessions meant for S.E.B.C., S.C. & S.T. by Birth are admissible to the Socially and Educationally Backward Classes, Scheduled Caste and Scheduled Tribe of Odisha only;**
- (vi) **Community/ Caste status once mentioned by the candidate in the online application form will be treated as final and the same shall not be changed subsequently under any circumstances.**
- (vi) Before appointment, a candidate must register himself/herself under the Odisha Medical Registration Act, 1961.
- (vii) If a candidate has at any time, been debarred for a certain period/chance(s) by the Odisha Public Service Commission or other State Public Service Commission or U.P.S.C. from appearing at any examination / viva voce test, he/she **will not be eligible** for such recruitment for that specified period / chance(s);
- (viii) **Only those candidates, who possess the requisite qualifications, are within the prescribed age limit and fulfill other eligibility conditions etc. by the closing date for submission of online application form, will be considered eligible;**
- (ix) A candidate who claims change in his/her name after having passed the H.S.C. examination, is required to furnish copy of publication of the changed name in the local leading daily newspaper as well as copy of notification in the Gazette in support of his/her change of name;
- (x) Every candidate selected for appointment shall be examined by the Medical Board. A candidate, who does not satisfy the requirement after medical examination, shall not be appointed;

8. IMPORTANT POINTS:

- (vii) **Online applications submitted to OPSC, if found to be incomplete in any respect, are liable for rejection without entertaining any correspondence with the applicants on the score;**
- (viii) A candidate found guilty of seeking support for his/her candidature by offering illegal gratification or applying pressure on any person connected with the conduct of the recruitment process or found indulging in any type of malpractice in course of the selection or otherwise, shall, in addition to rendering himself/herself liable to criminal prosecution, be disqualified not only for the recruitment for which he/she is a candidate, but also may be debarred, either permanently or for a specified period, from any recruitment or selection to be conducted by the Commission;
- (ix) **Admission to examination will be provisional. If on verification at any stage before or after the examination it is found that a candidate does not fulfil all the eligibility conditions, his/her candidature will be liable to rejection. Decision of the Commission in regard to eligibility or otherwise of candidate shall be final;**
- (x) This advertisement should not be construed as binding on the Government to make appointment;
- (xi) Any misrepresentation or suppression of information by the candidate in the application form will result in cancellation of his/her candidature or penalty, as decided by the Commission;
- (xii) Mere empanelment in the select list shall not confer any right for appointment unless the Government is satisfied after making such enquiry as may be deemed necessary that the candidate is suitable in all respects for appointment to the service;

9. CERTIFICATES / DOCUMENTS TO BE ATTACHED:

Candidates who qualify in the written examination shall be required to bring with them the hard copy of online application form along with copies of following relevant certificates/documents and originals of the same for verification of their eligibility as per terms and conditions of the advertisement, the date of which will be notified later on in due course, failing which his/her application will be rejected for the said post. The candidates are required to mention on each copy of documents **"Submitted by me"** and put their **full signature and date on the same**. **They must not attach the original certificates to their applications.**

- (i) H.S.C. or equivalent certificate in support of declaration of age issued by the concerned Board/Council;

- (v) M.D./M.S./ DNB /M.Sc./Ph.D/D.Sc certificate in support of qualification in the concerned Broad Speciality discipline as may be applicable issued by the concerned University/Institutions recognized by MCI/NMC;
- (vi) Mark-list in support of all the aforesaid examinations (i.e. H.S.C., MBBS, MD/MS/DNB/ M.Sc. etc.) passed including fail marks, if any, issued by the concerned Board/University;
- (vii) DNB training certificate if required;
- (viii) Experience Certificate from the competent authority for Tutor/Senior Residentship;
- (ix) Latest Medical Registration Certificate as per the Medical Registration Act, 1961
- (x) Certificate relating to passing of the screening test conducted by the National Board of Education as prescribed by the Medical Council of India vide Notification No. MCI-203(9) Regd. 2001, dated 13.02.2002 for Medical Graduate passing out of a foreign University;
- (xi) **Caste Certificate by birth in support of claim as SEBC/SC/ST , wherever applicable (Please see Note – 2);**
- (xii) No Objection Certificate issued by the competent authority Required;
- (xiii) Two recent passport size photographs (unsigned and unattested) with the printout / hard copy of online application form which has been uploaded;
- (xiv) Any proof of identity;
- (xv) Certificate from Competent authority in support of past service as in-service doctor serving on ad hoc basis or contractual basis under Government of Odisha in respect of candidates, who claim age relaxation as serving Doctors. The period of past service will be taken into account by the closing date of receipt of application.
- (xvi) Discharge certificate issued by the Commanding Officer of the Unit last served in case of Ex-Serviceman. They must submit an affidavit undertaking that he has not been appointed against any civil post after retirement from military service, wherever applicable;

NOTE 1: MBBS certificate, PG Degree Certificate, DNB Certificate, MSc Certificate, Ph.D Certificate, DSc Certificate, teaching experience certificate, Caste Certificate & Discharge Certificate of Ex-Serviceman must have been issued by the competent authority within the last date fixed for submission / receipt of online application form.

NOTE 2:

- (i) Candidates claiming to be belonging to S.E.B.C/ S.C. /S.T categories of Odisha by birth are required to submit copy of the relevant Caste Certificate issued by the competent authority in the prescribed form. Candidates of SEBC category (other than Creamy layer) must submit copy of Caste Certificate issued by the competent authority within the last 03 years from the last date of submission of online application form.
- (ii) Women candidates belonging to S.E.B.C./ S.C. / S.T. Categories are required to submit Caste Certificates by birth showing "daughter of". Caste Certificates by virtue of marriage (i.e. showing "wife of") are not acceptable and liable to rejection.

- (v) The competent authorities are: - District Magistrate/ Collector or Additional District Magistrate or Sub-divisional Magistrate/Sub-Collectors or Executive Magistrates or Revenue Officers, not below the rank of Tahasildar /Additional Tahasildar of Government of Odisha.

- (h) Suppression of facts / information about eligibility, if any.
- (i) Any other ground as per the decision of the Commission.


