**II.A. MINIMUM EDUCATION QUALIFICATIONS:**

**Graduate (Engineering) Apprentices:-**

- A degree in Engineering or Technology (Full time) granted by a recognized statutory university in relevant discipline.
- A degree in Engineering or Technology (Full time) granted by an Institution empowered to grant such degree by an Act of Parliament in relevant discipline.
- Graduate examination of Professional bodies (Full time) recognized by the State Government or Central Government as equivalent to above.

**Degree (Non-Engineering) Apprentices (Finance & HR):-**

- An Accounts Executive job role under PMKVY.
- MBA (HR)/MSW/Post graduate Diploma in Personnel Management/Personnel Management & Industrial Relation (2 Years full time Course) granted by recognized University & Institute.

**Technician (Diploma Holders) Apprentices:-**

- A Diploma in Engineering or Technology (Full time) granted by a State Council or Board of Technical education Established by a State Government in relevant discipline.
- A Diploma in Engineering or Technology (Full time) granted by a University in relevant discipline.
- A Diploma in Engineering or Technology (Full time) granted by an Institution recognized by the State Government or Central Government as equivalent to above.

## **II.B.OTHER ELIGIBILITY REQUIREMENTS:**

1. Candidates should have passed the qualifying exam in 2021/2022/2023.
2. Candidate should be belonging to the State of Rajasthan are only eligible.
3. Candidate should not have undergone or presently undergoing Apprenticeship Training in NLC India Limited or elsewhere.
4. Candidate should not have experience of one year or more in any job.

Applicants desiring to avail age relaxation under OBC category ought to submit the valid OBC Certificate (Back Class/ Most Backward Class Certificates shall not be accepted for consideration under OBC). °

## **AGE:**

Age limit will be followed as per Apprenticeship Rules.

## **III. RESERVATION OF VACANCIES:**

Guidelines under Apprentices Act on Reservation for SC/ST/OBC/EWS/PWD will be followed. Those who are claiming reservation under SC/ST/OBC/EWS/PWD shall provide certificate as per Government standard format, failing which their claim for reservation will be considered as 'General' category only. BC/MBC candidates claiming OBC (Non creamy layer) category should submit OBC (NCL) certificate as per the approved (OBC\_NCL) format from the certificate issuing authority.

Out of total training slots & seats, 50% have been allotted for Wards of Project Affected Persons (PAP'S) of Barsingar Project & 10% have been allotted for Wards of Employees of NLCIL.

## **IV. INSTRUCTION TO CANDIDATES:**

1. The Candidate will have to arrive at the percentage of marks obtained in the qualifying examinations as stated below and enclose it along with the application form.(refer Specimen format).
2. Overstatement of Marks by the candidates will lead to disqualification of the candidates from selection process.
3. In case of more than one candidate scoring the same percentage of marks at the cut-off level, the senior most candidates will be considered for selection, based on the date of birth.
4. Any misrepresentation/forgery of facts in the qualifying examination will lead to direct disqualification and may face consequences.

**Completion of Training does not entitle the candidates any right to claim Temporary or Permanent nature of job in NLC India Ltd.**

## **V. METHOD OF SELECTION:**

### **a) Graduate (Engineering), Post Graduate(HR/Finance) & Technician Apprentices:-**

**Selection will be based on percentage of marks scored by the candidates in qualifying Degree/Diploma, as the case may be.**

1. The percentage of marks obtained by the candidate in Bachelors degree/ Diploma/Master's Degree and as awarded in the final qualifying examinations will be calculated based on the practice followed by the University/Institution from where the candidates has obtained the Degree/Diploma.
2. In case the candidate is awarded grades/CGPA instead of marks, the percentage of marks will be based on the procedure followed by the University /Institutions from where he/she has obtained the Bachelors Degree/ Diploma/Master's Degree.
3. In the absence of any established scheme in the University/Institution for calculation of percentage of marks, the following principles will apply
  - a) In case the candidate is awarded Grades/CGPA, then the equivalence in percentage of marks will be established by multiplying the Grade/CGPA by a factor of 10.
  - b) In case the candidate is awarded marks semester wise, then the equivalence in percentage of marks will be established by taking the average of percentage of marks obtained by the candidate in all semesters from II year to final year, considering the semester wise average.
  - c) In case the candidate is awarded marks year wise, then the equivalence in percentage of marks would be established by taking the average of percentage of marks obtained by the candidate in all the years II year to final year, considering year wise average.
